## THE RULES OF THE 60/40 EXCHANGE

Members of the 60/40 exchange agree to the following:

1. Members promise to sell their goods and services at regular retail prices and at advertised prices.
2. Members selling goods or services promise to pay 4% of the sales price to the exchange withing 30 days of billing.
3. Members buying goods or services also promise to pay 4% of the purchase price to the exchange withing 30 days of billing.
4. Members promise to pay sales tax in cash if applicable at the time of purchasing any good or services that are taxable.
5. Members promise to pay any gratuities in cash at the time of purchase.
6. Member account numbers and passwords are strictly for the use of members and members' employees. Members promise not to share account numbers or passwords with non-members.
7. Members understand that purchases and sales made through the exchange are taxable events. Members understand that they are responsible for paying income taxes on all exchange transactions.
8. Members promise to update the Exchange with current Federal Tax I.D. numbers or social security numbers before December 31st of each year.
9. Members promise to review their monthly billing statements promptly and to report error within 15 days of the billing date in order to ensure corrections.
10. Members understand that 60/40 trade credits cannot be converted to cash. Members promise not to exchange trade credits for cash or to offer trade credits for cash or for currency of any nation.
11. Members who violate the rules of the exchange are subject of suspension and/or termination of their membership.
12. In case of disputes between members, the members agree to submit this dispute to the Exchange for arbitration and resolution.
13. The Exchange may modify and add to these rules from time to time and members shall have 30 days to review and comment on changes before they take effect.
